## **Minutes of Meeting**

#### **September 16, 2020**

The meeting was called to order by President Dinelli at 6:05 pm via a Zoom teleconference. In attendance besides President Gerry Dinelli were Trustees, Edmund Linscheid, , Kevin Confetti and Jay Gudebski. Also in attendance were Secretary Chris Lanzafame, Nancy Lanzafame, Bob Pinkston, Matt Stretch, Bill Luippold, Shawn Kelly, and Michael Linscheid.

Minutes of the meetings of May 21 and June 3, 2020 were approved as read. The date on the June 3<sup>rd</sup> meeting was corrected by the Secretary at filing to show it was 6/3/20 instead of 6/3/10. (Moved Linscheid/seconded Confetti)

Mr. Lanzafame discussed the financial report that is attached to these minutes.

The first proposal to authorize the District to use District and DWR subvention funds of up to \$40,000 on repairs on the Sacramento was approved unanimously. (Moved Linscheid/seconded Confetti)

The second proposal to approve no changes to the Conflict of Interest Code was approved unanimously. (Moved Confetti/seconded Linscheid)

The third proposal to approve the bid on the Riverdog PAI pump replacement project for \$22,400 was approved unanimously. (Moved Confetti/seconded Linscheid)

The fourth proposal to replace the Hit and Miss gate for \$24,500 was approved unanimously. (Moved Linscheid/seconded Gudebski).

Mr. Lanzafame stated that the PAI project reimbursements have been temporarily suspended due to State Funding concerns due to Covid so some of the projects may be delayed depending on funding and District cash flow.

Mr. Confetti and Mr. Pinkston brought up concerns that the Honker Bay levee has deteriorated dramatically in recent months and that it was in great need of repair. They both felt that the levee would not make it through a normal winter and that there could be beaver dens causing the levee crown to collapse that that this levee is in the worst shape it has been in ever. Most of the damage stems from the floods of 2017 and no repairs have been done to date. Mr. Lanzafame stated that Emily Pappalardo our engineer from MBK had viewed the sites and had figured some quantities of material to make repairs. It was discussed that the District should approve up to \$40,000 of funds to do an emergency repairs on the Honker Bay problems before winter. The engineers could extend the work to the Sacramento Levee contractors by doing a time and material project.

A motion to approve up to \$40,000 to complete these repairs was made by Mr. Confetti and seconded by Mr. Linscheid and the project passed unanimously.

The group discussed flood dates for the hunting season and flood date of October 12<sup>th</sup> was set.

A motion was made by President Dinelli to adjourn at 7:05 and was seconded by Mr. Linscheid and approved unanimously.

- **4.19.21.1 RESOLVED** that the work included in Reclamation District No. 1607's ("District") 2021-2022 Delta Levee Subventions Program Application consists of the maintenance and/or repair of existing levee improvements which involves negligible or no expansion of said improvements' existing uses and, hence, falls within the categorical exemption to the California Environmental Quality Act set forth in California Code of Regulations, title 14, section 15301; that said work does not constitute an exception to the exemptions of the California Environmental Quality Act; and that the District's Engineer is authorized to prepare and file with the County of Solano the appropriate Notice of Exemption on behalf of the District.
- **4.19.21.2 RESOLVED** that the President or Secretary of Reclamation District No. 1607 be and hereby is authorized to execute on behalf of this District that Agreement between The Reclamation Board of the State of California and Reclamation District No. 1607 covering participation in the Delta Levee Subventions Program pursuant to Part 9, Division 6 of the Water Code as amended by SB 34, Chapter 28, Statutes of 1988 for fiscal year 2021-2022 and the work to be reported to the State thereunder is determined to be categorically exempt under the California Environmental Quality Act (Pub. Resources Code, § 21000 et seq.) for the reasons set forth above.
- **4.19.21.3 RESOLVED** that the intention of the Board of Trustee's approval of the Sacramento levee Repair project in the minutes of September 16, 2020 was previously authorized by the Board's intention to authorize the District President or Secretary to enter into an agreement with the Department an action that was omitted from the agenda and minutes of the meeting of June 3<sup>rd</sup>, 2020.

The language of the September 16 minutes states: "The first proposal to authorize the District to use District and DWR subvention funds of up to \$40,000 on repairs on the Sacramento was approved unanimously. (Moved Linscheid/seconded Confetti)" refers to the District's intention to be included in the Subventions program for 2020-2021. It is therefore resolved in proposal **4.19.21.2** that the District President and the District Secretary were authorized using the same language as resolutions 4.19.21.1 and 4.19.21.2 for the past 2020-2021 fiscal year.

# Reclamation District 1607 CONFLICT OF INTEREST CODE

The political Reform Act (Government Code sections 81000, et seq.) requires local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted Title 2 of the California Code of Regulations, section 18730, which contains the terms of a standard conflict of interest code and may be incorporated by reference in an agency's code. Therefore, the terms of 2 CCR section 18730, and any amendments to it adopted by the Fair Political Practices Commission, are hereby incorporated by reference in this code. This regulation and the attached appendices designating positions and establishing disclosure requirements shall constitute the Reclamation District 1607 (District) conflict of interest code.

The members of the District's Board of Trustees and individuals holding designated positions shall file a Statement of Economic Interest Form 700 in accordance with the disclosure categories listed in the attached Appendix B. The Statement of Economic Interest shall be filed with the District's filing officer, and if so required, with the District's code reviewing body, the Solano County Board of Supervisors. The District shall make the statements available for public review, inspection and reproduction. (Gov. Code section 81008.) Upon receipt of the statements for the District's Board members and the District Manager, the District shall make and retain a copy and forward the original of these statements to the Solano County Board of Supervisors.

The provisions of all Conflict of Interest Codes and amendments thereto previously adopted by the District are hereby superseded.

#### **Disclosures for Third Party Consultants**

Third party consultants are "designated employees" who must disclose financial interest as determined on a case-by-case basis by the District Manager or his/her designee. The written determination of the District Manager or designee shall include a description of the consultant's duties and a statement of the extent of disclosure requirements based upon that description. All such determinations are public records and shall be retained for public inspection along with this conflict of interest code.

For purposes of this section and for compliance with the Political Reform Act and 2 CCR section 18701, a consultant is defined as an individual who, pursuant to a contract with the District, makes a governmental decision whether to:

- 1. Approve a rate, rule or regulation;
- 2. Adopt or enforce a law;
- 3. Issue, deny suspend, or revoke a permit, license, application, certificate, approval, order or similar authorization or entitlement;
- 4. Authorize the District to enter into, modify, or renew a contract that requires District approval
- Grant District approval to a contract that requires District approval and in which the District is a party, or to the specifications for such a contract;
- 6. Grant District approval to a plan, design, report, study or similar item; or
- 7. Adopt or grant District approval of District policies, standards or guidelines.

A consultant also means an individual who, pursuant tot a contract with the District, serves in a staff capacity with the District and in that capacity participates in making a governmental decision as defined in 23 CCR section 18702.2 or performs the same or substantially all the same duties for the District that would otherwise be performed by an individual holding a position specified in the District's conflict of interest code. (2 CCR section 18701.)

# APPENDIX B DISCLOSURE CATEGORIES

#### Category 1:

A person designated Category 1 shall disclose:

- a. Interests in real property located entirely or partly within District boundaries, or within two miles of District boundaries or of any land owned or used by the District.
- b. Investments and business positions in business entities, and income, including loans, gifts, and travel payments, from all sources.

#### Category 2:

A person designated Category 2 shall disclose:

- a. Investments or business positions in or income from sources, which are contractors or subcontractors engaged in work or services of the type used by the District.
- b. Investments or business positions in or income from sources, which manufacture or sell supplies, books, machinery or equipment of the type used by the District.

Agreement for Payment and Extension of Time for New Agreement

Dear Mr. Lanzafame,

This agreement and modification of past agreements ("Agreement and Modification") is by and between California Resources Production Corporation ("CRC") and the Reclamation District No. 1607 ("District"). Reference is made to that Letter Agreement between the District and CRC dated May 17, 2017 and the Letter Agreement between the District and CRC dated November 12, 2019 ("CRC Letters") and that Letter Agreement between the District and Venoco, Inc. dated November 1, 2007 ("Venoco Letter") copies on file with CRC and District.

CRC and District agree to modify the CRC Letter as follows:

Paragraph (5) of the Venoco Letter shall be deleted and replaced in its entirety as follows:

It is agreed and understood that the District and CRC will enter into a new mutually agreeable agreement prior to January 1, 2022 regarding CRC's annual payment as it pertains to providing monetary assistance for levee and road maintenance on or about Van Sickle Island. If CRC elects to abandon all wells on Van Sickle Island, CRC shall provide District with a plan for removal and legal abandonment of said wells prior to January 1, 2022.

Paragraph (6) of the Venoco Letter shall be deleted in and replaced in its entirely as follows:

CRC agrees to pay district a one-time payment in the amount of Fifty Thousand Dollars (USD \$50,000.00) on or before June 1, 2021 for District's use to maintain the Van Sickle Island levee (as known between CRC and District).

By signing below, both parties agree that CRC's payment as described above in the new paragraph 6 shall satisfy any requirement CRC shall have in the CRC Letter and the Venoco Letter.

This Agreement and Modification shall inure and bind both parties, their successors and assigns.
